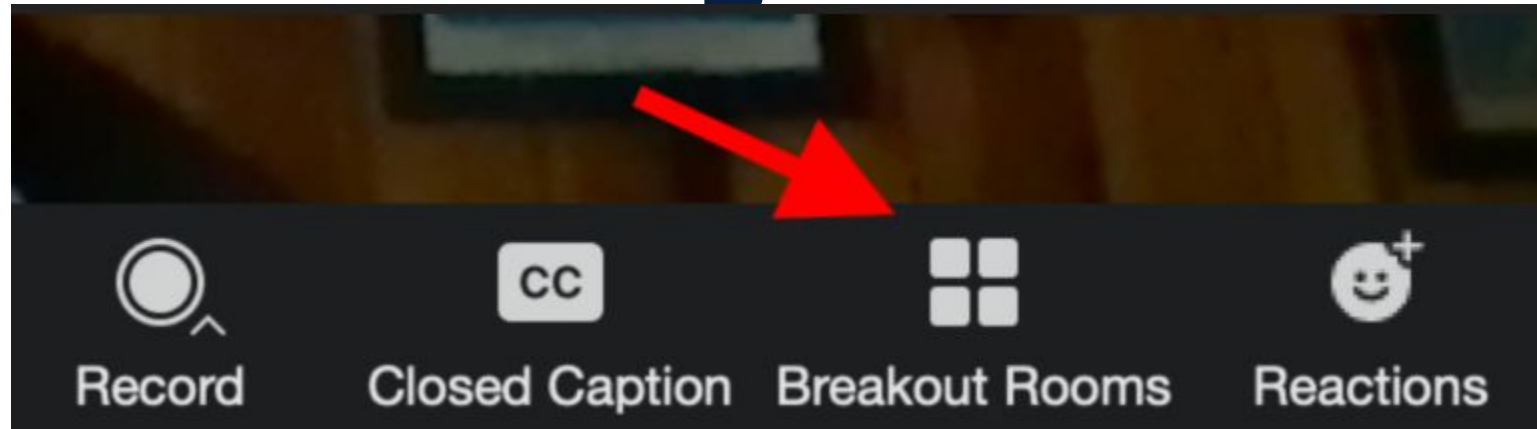

# Stipend Payments:

THE Accelerator participants are eligible for stipends, totaling up to \$1,000 for your time and commitment.

There are a couple exceptions, which include:

- Alumni from the Accelerator 2022, 2023 and 2024 class, will not receive these stipends.
- Participants who share an address are considered a “team” and will receive one stipend between them.



# Stipend Payments Schedule

There will be three payments over the course:

- \$250 paid after completing the first 5 sessions (including orientation)
- \$350 paid after completing 5 more sessions, or 10 total
- \$400 paid after completing all 15 sessions + an Exit Survey

After the final session, we will be sending participants an Exit survey, which is the final requirement to complete before the last payment.
